## Regulatory Information

The implementation date for CASS Cycle O has been deferred by the United States Postal Service® (USPS®) until August 1, 2021. The USPS Coding Accuracy Support System (CASS™) Cycle N will be valid through July 31, 2021. The USPS reserves the right to modify the “valid through” date in the future if conditions warrant it. The geocoder application shipped with GeoStan is CASS Certified for Cycle N in the Spring 2019 release version.

# Highlights and General Enhancements

## AddressBroker 4.8 and GeoStan 32.00

- **Added Master Location Data (MLD) Extended Attributes**  
Extended Attributes are now available with MLD. This new feature provides access to extended attributes associated with an addressable location that has a pbKey. When matching addresses with MLD, you can now seamlessly return additional property information associated with the address, such as APN, Elevation, Address Type, Lot Size, etc.
- **Added Residential Delivery Indicator (RDI™)**  
This United States Postal Service (USPS®) data product identifies whether a delivery type is classified as residential or business. If you are shipping to residences, you may lower costs by shipping with the Postal Service™ and avoid residential delivery surcharges typically charged by other shipping companies.
- **Improvements to Singleline Address Matching**  
Several enhancements to Singleline matching.
