1. Latest release

This document describes the enhancements and modifications included in the latest release of Data360 Govern, and highlights any changes that may affect your current implementation.

For information on previous releases, and for user and administration topics, please see the integrated product help. You can access the help by clicking the Help icon, positioned towards the right of the header bar.

1.1 What's new

Precisely Help Center

Our documentation is moving to the new [Precisely Help Center](#), where you can more easily personalize your experience and provide feedback to us. Using the new Help Center, you can:

- Bookmark topics and create a personalized content library
- Save your searches and get alerts when content is added or changed
- Print selected topics
- Send feedback to us and rate content

There is no change in how to access the documentation, you can continue to click the links from the product and this will take you directly to the new Help Center. The Release Notes are also available from the new Help Center and in future releases we will no longer publish a separate Release Notes PDF.

User interface enhancements

- When configuring diagram asset types, clicking on an asset now displays the configuration options in tabs, rather than in panels. For example, the **Field Definition** panel is now displayed as a tab when you select a diagram asset type.
- The full path of asset types is now included in the **Rebuild Partial Search Index** dialog on the **Administration > Settings** page, helping you to more easily locate the appropriate asset type. Additionally, the **Rebuild Partial Search Index** dialog now only shows the Status/Last Updated for any partial rebuild if it occurred within the last week.
- On the Configuration pages, for example **Configuration > Business Assets**, the **Open** and **Open in New Tab** options will now open the **Fields Definition** tab of the selected asset type. Previously, selecting one of these options opened the asset type list page.

Workflow tokens

A new workflow token has been added to workflow forms and emails to enable you to include the email address of the user who initiated the workflow. The token name is:

[WORKFLOW_INITIATOR_EMAIL]

DataProfiles v2.0 API

Two optional fields have been added to the data profiling endpoints:

- `popularityCount` - Gives the number of queries on the asset. Field type = long.
- `isAuthorizedForPopularity` - States whether the user is authorized to access the `popularityCount` statistics. Field type = boolean.

The `percentileStatistics` attribute has been enhanced to accept decimal values.

Other changes

- The description field on rule dimension reference lists has been converted from HTML to Simple Text. The Description field is now available to select from the **Available Field Tokens for Display Format**.
- When downloading custom export templates, a loading indicator is now displayed.
- You can now select Counter fields from the list of **Available Field Tokens** when editing the **Display Format** on an asset type.
